I co-founded, planned and coordinated the flagship Basic Income March of 2019 which went from Manhattan to The Bronx. Over 800 people participated, including experts in Universal Basic Income study and advocacy. I co founded Basic Income NYC, where I worked with a team to hold ongoing events called Basic Income Movie Nights, from 2015 to 2019. I've provided policy analysis to former NYC Councilmember Daniel Dromm, as well as to Andrew Yang during his campaign for President.

As a writer and communicator, I have published two dozen articles and opinion pieces and one book chapter, have presented at conferences in the U.S. and abroad, have met with key people in government and society, and have been a guest on podcasts and online sessions to discuss poverty and anti-poverty policy.

I conducted social history interviews for students in the evaluation process of the Committee on Special Education and helped parents to understand the process and the services; I provided support to families during the IEP reviews and the evaluation process. I helped parents to obtain resources and aid in the community for their families. I supported students during school shutdowns and hybrid schedules due to COVID-19 with virtual counseling sessions as well. In 2021, the Chancellor of NYC Schools violated our union negotiated labor contracts and terminated tenured educators because we declined to participate in taking the untested Covid19 vaccine.

December 2013- March 2015

Jewish Board for Family and Children's Services: Social Worker, Tier II shelter for families Queens, New York

I helped moms and kids living in our shelter to get income and other resources restored when they were cut off from public assistance programs such as TANF. Moms came to me for help with their apartment searches. I also held formal supportive social groups weekly with moms to help them stay strong while they were experiencing homelessness. I accompanied moms to social services appointments and intervened to restore funds when benefits were cut off. I assisted our organization to implement safety reforms after a "near miss" incident in our shelter. One thing I am very proud of is that I saved one mother's life when I made the decision to take her to another ER when she was sent home sick by the local hospital—it turned out she had been misdiagnosed. The shelter director had refused to provide me petty cash to take her to the better hospital that was further away, so I used my own money. My decision saved this mother's life.

April 2012-August 2013

Winston Medical Staffing: Counseling and social work at St. Luke's/Roosevelt Hospital Psychiatry New York, New York

I served as case manager and did crisis intervention for inpatient psychiatric patients, including intensive encouragement to follow discharge plans. Helping to calm nervous patients was an essential part of the work. I helped families with discharge planning. I provided support to Spanish speaking patients bi-lingually.

January 2008-March 2011

Social Worker/Asthma Counselor

Metropolitan Hospital Center, New York, New York

I managed a social services and asthma education program for one of the largest public hospitals in the City. My home visits, advocacy to get families basic resources, and my analysis of the program to chiefs of staff resulted in a significant decline in emergency room visits for kids with asthma as well as improved home management of asthma. I am proud that I went above and beyond my job description to get Department of Health "Healthbucks" vouchers to the families who used our pediatric asthma clinic—an estimated income boost of \$2,500 each summer.

I planned and carried out outreach, advocacy, and public relations for our national women's policy project, the *Caregiver Credit Campaign*, to amend federal tax law to benefit unpaid caregivers.
